



# Canada Day A KICK OFF TO SUMMER

As much as Canada Day is a decentralized festivity, the official celebrations are in Ottawa, in the region of Ontario. The parliament promotes concerts and cultural events in the presence of the General Governor and Prime Minister.

FESTIVALS ACROSS THE COUNTRY

his holiday has been celebrated since 1867, when it was promulgated the Constitutional Act in Canada. This event also is known as The British North America Act, uniting three colonies: Nova Scotia, New Brunswick, and the Province of Canada (nowadays Ontario and Quebec), making them a single dominion in the British Empire, Canada.

At that time, despite being part of the British Empire, Canada had more political autonomy and governance. With time, the country obtained more and more independence, mainly with the approval of the Statute of Westminster in 1931. But it was just until 1982 with the approval of the Constitution Act, that Canada became completely free.

Initially, the commemoration was named as Dominion Day, but in 1982 it was officially renamed to Canada Day.

Canadians celebrate Canada Day by attending outdoor events, such as festivals, carnivals, parades, concerts, fireworks, and much more. As the commemoration happens throughout the national territory, without connection between one place and another, there is no pattern: each city does it in its own way. But, in general, these are the common activities during party day.

This is the main holiday of the country, then Canadians are very participative, going to the streets dressed or painted in white and red, which are the flag colors. At last, this holiday represents the national effort to become completely independent.

As we mentioned, Canada Day

is celebrated in the whole country, but also in other cities outside the Canadian border. Therefore, if you have relatives or friends that live in other countries and want to celebrate this date with them by sending money, count on Western Union Canada.

Most communities across the country will host organized celebrations for Canada Day, usually outdoor public events, such as parades, carnivals, festivals, barbecues, air and maritime shows, fireworks, and free musical concerts, as well as citizenship ceremonies for new citizens. There is no standard mode of celebration for Canada Day; professor of International Relations at the University of Oxford Jennifer Welsh said of this: "Canada Day, like the country, is endlessly decentralized. There doesn't seem to be a central recipe for how to celebrate itchalk it up to the nature of the federation." However, the locus of the celebrations is the national capital, Ottawa, Ontario, where large concerts, presided over by the Governor General, are held on Parliament Hill, as well as other parks around the city and in Hull, Quebec. The sovereign may also be in attendance at Canada Day celebrations in Ottawa; Queen Elizabeth II was present in 1990, 1992, and 1997. The Queen also helped celebrate Canada's 100th anniversary on 1 July 1967.

Under the federal Holidays Act, Canada Day is observed on 1 July unless that date falls on a Sunday, in which case 2 July is the statutory holiday, although celebratory events generally take place on 1 July even though it is not the legal holiday. If it falls on a Saturday, the following Monday is generally also a day off for those businesses ordinarily closed on Saturdays.

Canadians celebrate Canada Day in many ways including fireworks, parades, picnics, and events. Canada Day can also be viewed as a kick off to many of the festivals that happen across the country in July and August.



#### THE CANADIAN NATIONAL EXHIBITION

The Canadian National Exhibition in Toronto, known locally as "the Ex" is an annual event that takes place over the last two weeks in August. The Ex has over 1.4 million visitors annually and is one of Canada's largest annual fairs. Agriculturists, engineers, and scientists represent their country by exhibiting their discoveries. The grounds also have food stands, live entertainment, sporting events, a casino and a carnival with rides.

#### MONTREAL'S INTERNATIONAL JAZZ FESTIVAL

Saragarhi.



## THE PANTHIC LEHAR IN PUNJAB IN 2024



### LANDSLIDE WINS OF BHAI AMRITPAL SINGH AND BHAI SARABJIT SINGH KHALSA

he electoral victories of pro-Khalistan radical preacher Amritpal Singh from Punjab's Khadoor Sahib, and Sarabjit Singh Khalsa, the son of Beant Singh, have brought the focus back to the State's troubled past and voters' growing disenchantment with mainstream parties. According to the State observers, the traditional parties mostly stand discredited due to the growing burden of debt, corruption, farmers' distress, drug abuse and unrelenting overseas migration from Punjab.

Both Singh and Khalsa had contested as independent candidates in this Lok Sabha election. While Singh defeated Congress candidate Kulbir Singh Zira with a margin of over 1,97,120 votes, Khalsa defeated Aam Aadmi Party's (AAP) Karamjit Singh Anmol with a margin of over 70,000 votes.

During his campaign, Khalsa said that he was convinced by the community to contest the election. He galvanised support on the issues related to the desecration of the Sikh scripture Guru Granth Sahib, the release of Bandi Singhs (Sikh prisoners who completed their jail terms), the drug menace, Punjab's right over its river water and the farmers' demand for minimum support price on food crops.

Amritpal Singh remains in preventive custody under

the National Security Act (NSA), in Assam's Dibrugarh Central Jail for over a year now. Other candidates on the Khadoor Sahib seat, formerly a Shiromani Akali Dal (SAD) stronghold, included SAD's Virsa Singh Valtoha, a former aide of the slain Sikh militant leader Jarnail Singh Bhindranwale; Laljit Singh Bhullar of AAP; and the former MLAs Kulbir Singh Zira (Congress) and Manjit Singh Mianwind (Bharatiya Janata Party).

Khadoor Sahib was the epicentre of militancy and is also home to several important Sikh shrines. As the area remains in the grip of drug abuse and agrarian distress, Amritpal Singh acquired a reputation for his campaign against drug addiction. Security forces launched a crackdown on his Waris Punjab De ('Inheritors of Punjab', a Sikh volunteer political group campaigning for a separate sovereign Sikh State) March last year, when he disappeared from the public sight. He was arrested after a month-long manhunt in Moga's Rode village, the birthplace of militant leader Bhindranwale who was killed in Operation Blue Star.

The Sikh separatist movement which calls for the establishment of a separate Sikh homeland, or Khalistan and its impact also found a mention in the Pew survey which said, "Sikh-Hindu relations were marked by violence in the 1970s and 1980s, when demands for

a separate Sikh state covering the Punjab regions in both India and Pakistan (also known as the Khalistan movement) reached their apex".

Meanwhile, Sikhs were also more likely than other religious communities to see communal violence as a problem in the country. 78 percent of them rated communal violence as a major issue against 65 percent of Hindus and Muslims, the survey showed.

Sarabjeet Singh Khalsa is a resident of Mohali, and the 45-year-old has unsuccessfully contested three elections in 2004, 2007 and 2014 the former two on a Shiromani Akali Dal (Amritsar) ticket and the last on a Bahujan Samaj Party ticket.

members His family successfully contested elections years earlier. In 1989, his mother, Bimal Kaur Khalsa, won the Lok Sabha polls from Ropar, while his grandfather Sucha Singh won the Bathinda seat both on Shiromani Akali Dal (Amritsar) tickets.Both Khadoor Sahib and Faridkot are parliamentary seats on the international border with Pakistan. The victory of radicals on these seats will likely give a strong fillip to the consolidation of the otherwise marginalised extremist forces in the state.

"The rising popularity of the radicals, as it may seem from the election results, is going to pose the biggest problem for the Bhagwant Mann-led AAP government in the state. Does Mann have the political maturity and the sagacity to deal with the possibility of the emergence of such forces remains to be seen," said professor Jagrup Singh Sekhon, formerly with the political science department of the Guru Nanak Dev University in Amritsar. Professor Paramjit Judge, a renowned historian, told that while this development in the election results isn't expected to have much of an immediate impact on Punjab politics, it was the direct result of the failure of the AAP to stitch up an alliance with the Congress in Punjab as had been done at the national level. "The alliance would not

have given space to any other force to rise. But the personal egos of the

leaders involved did not allow that to happen.

All eyes will be on the Mann government — how it handles this sentiment. Though, they do not have much of a reputation in this field. More often than not, they have been criticised for flirting with the radical elements themselves," added Kaur.

It is pertinent to mention here that behind the victories of Amritpal and Sarabjeet was the ghost of Punjab's unsolved issues such as the farm crisis, SYL canal row, transfer of Chandigarh to Punjab, justice in the extra judicial killings of youth during militancy, slapping of UAPA and NSA cases against youth.

All these issues collectively created a political void, which, coupled with the mistrust on traditional politics by a section of Sikh voters led to the two independents winning big in the 2024 Lok Sabha elections.

Most of the Sikhs wanted to correct this mistake, and hence there was a collective agreement over the fact that Amritpal should win this time. However, with this development, polarization will increase in Punjab. This will also have an impact on Punjab's Dalit politics. The way AAP won in the 2014 parliamentary polls—the party had won four Lok Sabha seats in Punjab—shocked the entire nation, the same way radical politics is rising in Punjab now.



# WHAT NARENDRA MODI 3.0 MEANS FOR INDIA

The resounding victory of the Bharatiya Janata Party (BJP) coalition in India's federal election represents a key marker in the modern history of India. It was the most extensive and probably most expensive election campaign in the country's history, with 900 million voters casting their votes in one million polling stations over 38 days. Some 83 million Indians were first-time voters.

he great Indian festival of democracy—as the elections are often called—is seen as the most challenging exercise in making all Indians feel they have a say in the running of the government.

And the return of Narendra Modi as prime minister is both an opportunity and challenge for the country.

The 2019 parliamentary elections were the most "presidential" since the era of prime minister Indira Gandhi four decades ago, with a focus more on the personality of one leader (and his track record) than the candidates standing for office and their respective parties.

Modi's larger-than-life presence

Modi was projected as the only leader who would revive the great Indian civilisation and save the country from the powerful elites and corrupt politicians who made up what the BJP deemed the "anti-national" opposition.

At times in the campaign, his personality assumed almost mythological proportions. The defining image was of the Indian leader shedding his regal robes and retreating to a bare cave, close to one of the important

centres of Hindu pilgrimage, where he meditated in a monastic saffron shawl. This reinforced his popular image as a puritanical and incorruptible leader whose first choice in life was to be a monk.

In contrast to this imagery, the opposition parties ran lazy, tired campaigns that failed to

have much impact.

The Congress party, the country's once-dominant political party, did not improve much on its devastating results from the last 2 elections. Priyanka Gandhi Vadra, the sister of Congress president Rahul Gandhi, tried hard to mobilise voters with rousing speeches and campaign events, but these were just brief moments in the longest campaign in Indian electoral history.

The Congress party's traditional hubris showed little signs of abating

as it abandoned any chance of building potentially winning coalitions that could have countered the Modi juggernaut.

The only real resistance to the BJP-led coalition came from India's largest state of Odisha & Madhya Pradesh, where two strong regional parties suspended their traditional rivalry to establish an alliance.

In part due to these social welfare schemes, the BJP expanded its presence in states where it has traditionally had little previous success, including Bengal, Odisha, and many parts of southern India.

#### What Modi's win means for India

So, what can Indians expect from a BJP-led government for the next five years? Based on what we have seen

since 2019, the government will be centralised and driven primarily from Modi's office. Fortunately, the messiness of Indian democracy and the strengths of the constitution will prevent the country from leaning towards

> has shown it was possible to take a pragmatic approach to social and economic policies.

> There are many key challenges that will require a fine balancing act. These include a further liberalising of the economy, with the structural changes needed to make it easier to do business in India and attract more foreign investment. Creating jobs and skills training for the vast numbers of young Indians remains a formidable challenge, as does India's struggling agrarian sector, which has reached a crisis point.

It remains to be seen if the activism of the BJP's rankand-file members, as well as the party's supporters in the Hindu nationalist movement, can be managed without compromising on key policies that India needs for social cohesion and to continue growing the economy. It will also fall to Modi to reassure ethnic and religious minorities many of whom have fallen victim to Hindu mob attacksthat they are part of an inclusive vision for the country.

In terms of foreign policy, Modi has demonstrated deftness in New Delhi's relations with powers like China and the US, as well as other countries in the region. There are sure to be new challenges with Pakistan, in particular, as well as an increasingly belligerent China, but Modi has already shown he has a unique ability to build a personal rapport with other leaders.

Enter the 2023 SXR Series Supercharged Escalade. SVE didn't just add a host of parts to the Escalade's factory 6.2-liter naturallyaspirated V-8 engine and call it a day. Instead, the Escalade now gets a blueprinted aluminum block, race-quality computer-balanced rotating assembly, including forged 1538MV twisted steel crankshaft and forged aluminum pistons, upgraded cylinder heads, and a high-output supercharger assembly. Topping it all off is a custom stainless steel exhaust system that lets the engine breathe better and emit a more emotional sound.

he result of this transformation is an insane amount of power- 800 buff horses and 720 pound-feet of torque to be precise. For reference, the high-performance Escalade-V suddenly seemed underwhelming as its

supercharged 6.2-liter V-8 "only" produces 682 horsepower and 653 pound-feet. And while no 0-60 mph times were quoted by SVE, they claim that the SXR qualifies as the quickest 2023 limited-production full-size SUV. It's somehow believable considering that it even makes more grunt than the 710-horsepower Dodge Durango Hellcat.

All of that power will be for nothing if it did not come with any handling upgrades. Thankfully, SVE took that into account as the package comes with a large diameter heavy-duty rear sway bar and bushings to control its acceleration. The package also includes Brembo six-piston big front brake calipers and 16.1-inch vented rotors, which interestingly are supplied by Cadillac dealers. Of course with all that power, you naturally want to show it off somehow, right? SVE gave the Escalade a set of unique 22-inch alloy wheels and an 800HP badge at the tailgate. There's also various

exterior add-ons that delete the chrome trimmings in favor either black or body-colored ones. For a better stance, you can opt for two types of suspension. The first one is a sport suspension that drops the front and rear by 2 and 3 inches, respectively. The

other one is an adjustable lowering kit for Escalades fitted with the adaptive suspension. The

upgrades are much more minor in the cabin. These are limited to a SXR logos embroidered on the headrests and floor mats, along with SXR door sill plates. A numbered dash plaque and two numbered key fobs with the SXR emblem are also included. Lastly, a portfolio with the embroidered logo, owner's

manual, and window sticker are also included in the package.

So, how much do these upgrades cost? The SXR Series Supercharged Escalade (and Escalade ESV) rings it at \$69,995, and this is just for the conversion. Buyers will have to dish out that dough plus the additional Escalade V-8's MSRP of \$79,295. As mentioned, these upgrades are only meant for the 6.2-liter naturally-aspirated V-8, which means you can't add these upgrades if you bought the V-6 diesel or even the supercharged Escalade-V.


